Announcement to the investors

Eurobank Properties REIC announces that at the closing of yesterday's trading day in the Athens Stock Exchange, a limited in volume of share transactions were executed resulting in a decrease of 29,77% of the share price.

Given that the decrease in the share price, the low volume of transactions and how these transactions were executed, is not in line with the Company's fundamentals, the positive closing of the Greek Stock Exchange, or the historical fluctuation of our share price, a letter was sent today to the Greek Capital Market Commission requesting for the investigation of the matter.
