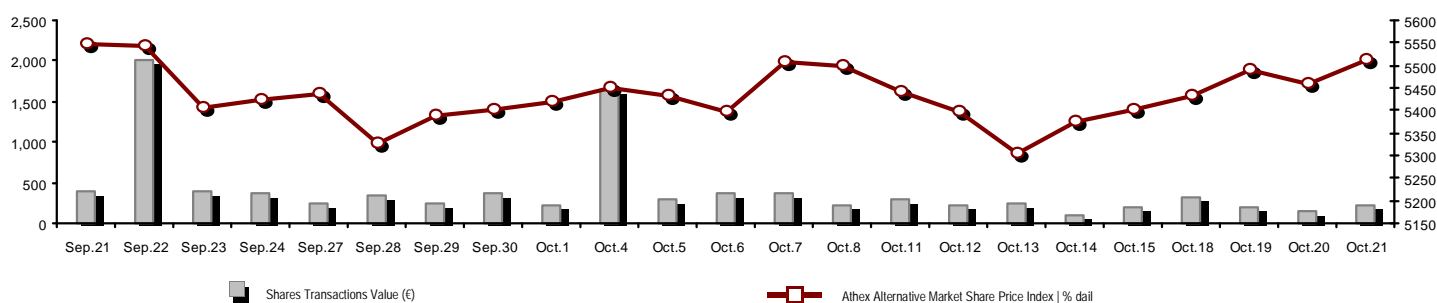

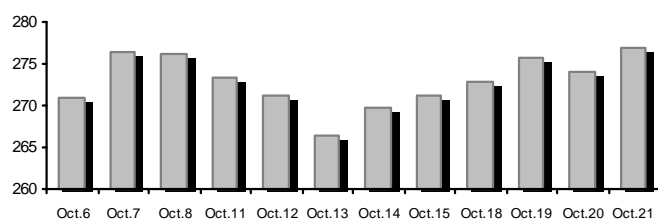

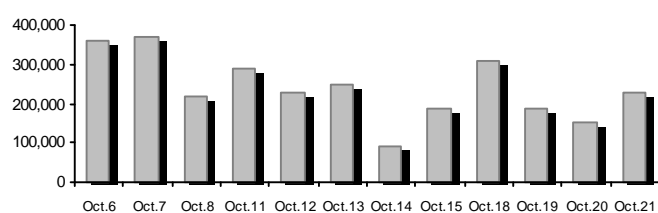
Athex Alternative Market Share Price Index vs Shares Transactions Value



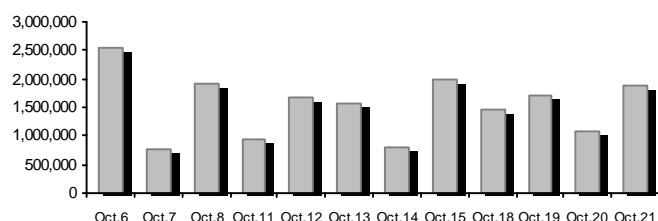

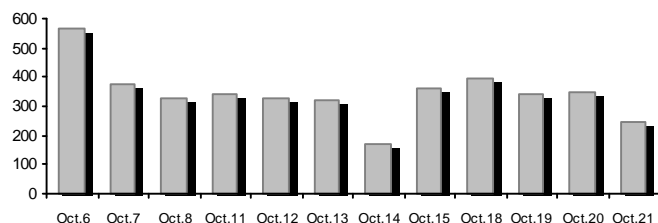

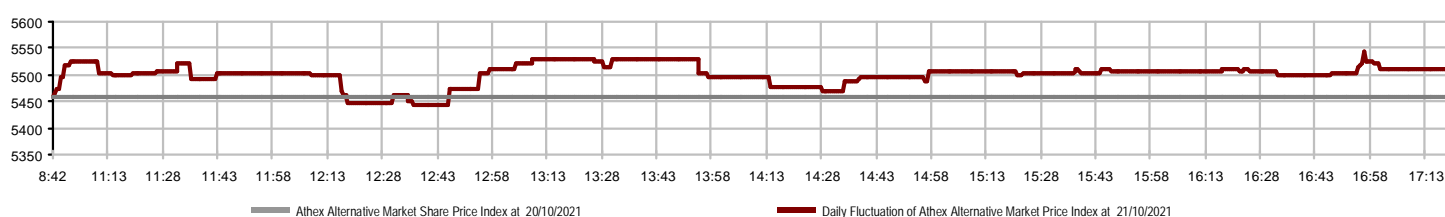
