TRADING PLATFORMS (TRADING VENUES)

TRADING ACTIVITIES

Trading for one's own account and/or for third parties (brokerage), Electronic trading systems for the purpose of generating orders, quoting or executing transactions in an automated and/or semi - automated manner (i.e. for algorithmic trading, black boxes, market making, automated execution, order management, smart order or the automated monitoring of trading activities)
