

**Notification of important changes concerning voting rights under L. 3556/2007 [21.04.2026]**

Pursuant to the provisions of Law 3556/2007, Alpha Bank A.E. ("Alpha Bank") announces that, according to the notification received on April 20th 2026 from Goldman Sachs Group Inc.in accordance with art.11 par.1 (a) and 1(b) of L.3556/2007, Goldman Sachs Group Inc indirectly holds, as of April 16th 2026, 31,309,212 common shares with voting rights representing 1.35% of the total voting rights of Alpha Bank and financial instruments, subject to physical or cash settlement, which may result in the acquisition of 83,983,700 common shares with voting rights, corresponding to 3.63% of the total voting rights of Alpha Bank.
