

Financial Results for the Fiscal Year 2025 ATTICA PUBLICATIONS SA

The ATTICA PUBLICATIONS SA Group of Companies announced the financial results for the Fiscal Year 2025 based on International Financial Reporting Standards (IFRS).

During the current fiscal year, the Group's turnover amounted to 21,931.06 thousand euros compared to 21,636.62 in the previous fiscal year, i.e. increased by 1.36%. In detail, advertising revenues amounted to 15,504.25 thousand euros compared to 15,853.93 in the previous fiscal year, presenting a marginal decrease of 2.21%, while revenues from sales of magazines and other products/merchandise, through the distribution agency, showed a significant increase of 17.1%, which amounted to 5,550.78 thousand euros compared to 4,738.68 in the previous fiscal year.

The Group's earnings before taxes, financial, investment results and total depreciation (EBITDA) decreased by 6.85% and amounted to 3,291.07 thousand euros compared to 3,533.92 thousand euros in the previous year. Profits before taxes increased by 2.40% and amounted to profits of 2,022.71 thousand euros compared to 1,975.33 thousand euros in the previous year. Net results after taxes increased by 12.59% and amounted to profits of 1,598.76 thousand euros compared to profits of 1,419.93 thousand euros in the previous year.

The turnover of the parent company amounted to 13,896.13 thousand euros compared to 12,978.69 the previous year, i.e. increased by 7.07%. In detail, advertising revenues amounted to 8,464.46 thousand euros compared to 8,202.33 the previous year, showing an increase of 3.2%, while revenues from sales of magazines and other products/merchandise, through the distribution agency, showed a significant increase of 18.26%, which amounted to 4,677.17 thousand euros compared to 3,954.88 the previous year.

The Company's earnings before taxes, financial, investment results and total depreciation (EBITDA) increased by 5.65% and amounted to 2,118.11 thousand euros compared to 2,004.77 thousand euros in the previous year. The results before taxes showed a significant increase of 1,428.64 thousand euros and amounted to 1,460.83 thousand euros compared to 32.19 thousand euros in the previous year, which was burdened with an extraordinary impairment loss of subsidiaries, totaling 1,001 thousand euros. The net results after taxes of the current year amounted to profits of 1,229.43 thousand euros, compared to losses of 250.36 thousand euros in the previous year.
